

## **Citizenship (Amendment) Rules, 2020.**

In exercise of the powers conferred by clause (e), of Section 18 of the Citizenship Act 1955 (57 of 1955), the Central Government hereby makes the following Rules, namely -

### **1. Short Title and commencement –**

(1) This Rules may be called THE CITIZENSHIP (AAMENDMENT) RULES, 2020.

(2) It shall come into force on the date of its publication by Notification in the Official Gazette of India.

### **2. Insertion of new rule 5B –** After Rule 6 of the Citizenship Rule, 2009, the following rule shall be inserted, namely –

**“6A.** Application for registration under Section 6B of the Citizenship Act 1955 – An application from a person covered under Section 6B of the Citizenship Act, 1955 for registration as a citizen of India shall not be entertained unless –

(a) the application is made in FORM IIA;

(b) he gives an undertaking in writing that he shall renounce the citizenship of his country in the event of his application being sanctioned;

(c) he belongs to minority communities of Afghanistan or Bangladesh or Pakistan, namely Hindus, Sikhs, Buddhists, Jains, Parsis and Christian;

(d) he has migrated to India on or before December 31, 2014 and is ordinarily resident in India for a period of at least six years on the date of making application;

(e) he makes the oath of allegiance as specified in the Scheduled of the Citizenship Act, 1955.
